As a provider you will need the following:

- CQC countersigned DBS (Registered Manager), non-CQC countersigned DBS (Nominated Individual)
- ICO registration certificate
- Public and employer liability insurance.

Develop Policies

Depending on your service and package, we will develop between 20 and 270 policies for the CQC application.

CQC Registration

- Provider application
- Registered Manager application
- Nominated Individual application where required.

CQC Engagement

The CQC will request information relating to some policies. You have 7 days to respond with up to 50 documents required - you must be ready or we can do the heavy lifting for you.

Refining your policies

The CQC will review your documents, then a response will be required, refining and updating documents in line with feedback. Again, you need to respond quickly or we can do it for you.

CQC Assessments

There will be assessments for the registered provider, the registered manager plus the Nominated Individual where required.

Facility Inspection

The CQC team need to ensure the environment is safe and ready to be operational.

- · You should add where the evidence is stored to support you in locating this in the future including when asked by the CQC.
- · Using this platform does not guarantee any CQC rating but it will help you to highlight areas you need to concentrate on.
- The platform will provide you with an ongoing plan purely based on what you enter. If you do not have evidence, we strongly recommend you do not mark that section as having evidence.


